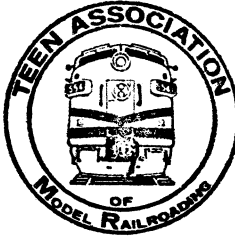

Proposed Amendments

Claude J. Morelli has submitted the following propositions to be voted upon by the membership:

PROPOSITION A:

Because it is grammatically incorrect (i.e. because it is impossible for there to be an association of model railroading), the name of the Teen Association of Model Railroading should be changed to "Teen Association of Model Railroaders."

PROPOSITION B:

Amend Article IV, section 2 of the TAMR Constitution to read: "A region is considered organized if it has an elected regional representative who may serve as its representative to the TAMR, and if it has a written set of by-laws to regulate its general affairs."

PROPOSITION C:

Amend Article IV, section 5 of the TAMR Constitution to read: "The TAMR Executive Board shall be the final authority on all inter-regional and intra-regional disputes."

David M. Holden has submitted the following propositions to be voted upon by the membership:

PROPOSITION D:

Ad a new section to article IV stating: "Persons wishing to belong to organized regions and receive their newsletters must be TAMR members. No other benefits of the regions may be shared by non-TAMR members except for promotional purposes. This section becomes effective with all new or renewed applications to regions beginning August 1, 1986."

PROPOSITION E:

Ad a new article to the Constitution saying: "To prevent the TAMR or its members from being harmed by imprudent members, the TAMR Executive Board has the authority to do the following:

A. By a majority vote, revoke a membership to the TAMR because a member has not, on more than one occasion, not abided by the TAMR Constitution and its by-laws.

B. By a majority vote, bar a member(s) from participating in TAMR activities.

C. By a majority vote, revoke a membership to the TAMR because of a member not following TAMR Executive Board orders."

Officer Candidates

Below is the list and platforms for the respective offices from the candidates.

OFFICE OF THE AUDITOR - 1986-1988

John Huseby, III

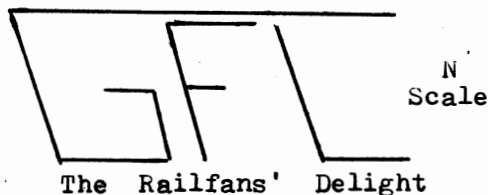

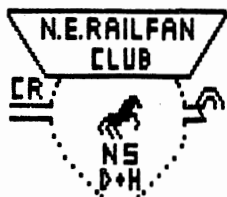

We do N scale (Only) locomotive repair!
FACT: GFL now has the CS Models Express truck in N scale. It is a real nice model and can be painted to suit the individual taste. It has real nice detail considering the small size. This model is made of metal. I found this kit quite easy to put together. The kit goes very nicely with Kadee wheel sets, it also is matched to the Kadee truck pins. Use them with body mounted couplers. **SUGGESTED USE:** Put the Atlas and Con-Cor REA cars on a Kadee chassis, mount these trucks and the body mount couplers. This gives the train a real nice head end look. You could also remove the word "refrigerator" from the side of the car and put the Con-Cor corrugated coach diaphragms on the ends of the box cars. This gives them the REAL look of the headend equip. stuff.. It puts the flow of the train in better perspective as well as having the diaphragms in there. They're \$4.95 + \$1.00 postage.

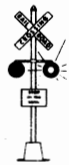

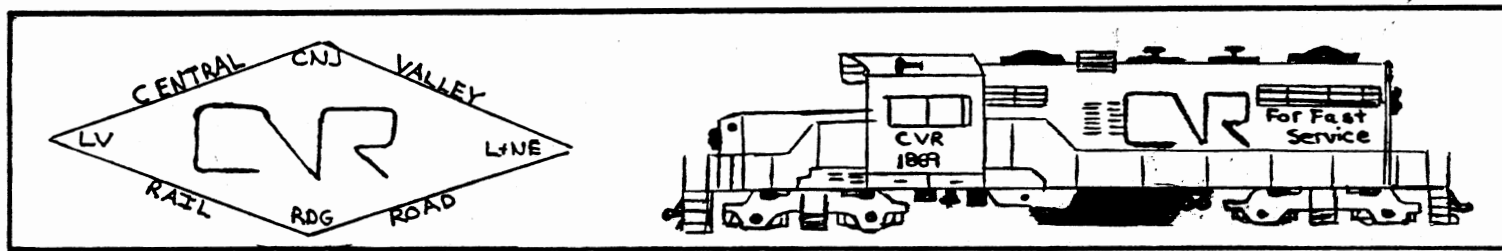
